 To Greenville District, by these presents  
 Thomas Chiles that I Chaney Strand of the District and  
 State aforesaid, in consideration of one hun-  
 dred dollars to me in hand paid by Thomas Chiles of District  
 and State aforesaid, have granted, bargained, sold and released  
 and by these presents do grant, bargain sell & release unto  
 the said Thomas Chiles a tract or parcel of land, situated  
 lying and being in the District & State aforesaid, on the waters  
 of Saluda River containing sixty acres more or less, it being  
 part of a four thousand acre tract, granted to Robert Prince  
 by his Excellency William Moultrie and bounded as follows:  
 Beginning at the head of branch of branch on a White  
 Oak corner, thence S. 40 W. to a path on a Stake corner, thence  
 on the said path, to a hickory corner Saml. W. Jenkins line  
 now given Tally, thence along his line N. 80. E. to Red oak blazed  
 by David McCoy & Isaac Wilkins thence a conditional line  
 to a Stake corner, thence to the Beginning. Post hole and  
 Post Hold, all and singular the rights members, heredita-  
 ments and appurtenances, unto the said Thomas Chiles this  
 day forever and I do hereby bind myself my heirs and  
 Executors and administrators to warrant, and forever defend  
 all and singular the said premises unto the said Thomas  
 Chiles, his heirs & assigns against myself & my heirs & assigns  
 every person whomsoever lawfully claiming or to claim the  
 same or any part thereof, witness my hand & Seal this
