Mrs Maria Harrison State of South Carolina Know all men by
 these presents that I John M Roberts of the
 District of Greenville and State aforesaid for and in consideration
 of the sum of One Hundred and fifty Dollars to me in hand paid
 by Mrs Maria S Harrison of the District and State above men-
 tioned have granted bargained sold and released and by these
 presents do grant bargain sell and release unto the said Mrs
 Maria S Harrison a certain tract piece or parcel of Land con-
 taining fifteen and one fifth acres be the same more or less sit-
 uate lying and being in the District and State aforesaid on
 waters of brushy creek of Reedy River on the Public Road lead-
 ing from Greenville Court House to Anderson Ct House. Be-
 ginning on a small post-oak near the road running thence N
