of the sum of one hundred dollars to me in hand paid by Samuel
Wade the receipt of in which is hereby acknowledged, have granted,
bargained, sold and released and by these presents do grant, bargain
and sell, and release and convey to the said Samuel Wade a cer-
tain tract or parcel of land situated lying and being in the Dis-
trict of Greenville, and State aforesaid, on the northern side of Salu-
da River, beginning at the mouth of branch on Saluda River on A.
Blythes line thence along said line to Stephen Paines line thence along
said line to a shole on the Heamy Smith Creek thence the myanders
of said Creek to the River thence down said River to the beginning;
or Blythes line on the river to the beginning containing one hundred
Acres, be the same there more or less, with all rights mentioned,
