Know all men by these presents, that I, Solomon Loftis, of Greenville District and State aforesaid, for and in consideration of the sum of Two Hundred Dollars to me paid by Jordan Loftis of Greenville District and State aforesaid, the payment whereof is herewith acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jordan Loftis, all that tract or lot of land lying and being situated in the District aforesaid, on the waters of Par Creek, the waters of South Tyger River, beginning on a post oak near the old school house thence S. 60 W. to a small red oak on the branch thence S. 30 E. 35.50 to a white oak near Par Mountain thence N. 65 E. to a Pine on Pinners line thence along Pinners line to the beginning corner containing by estimation fifty acres more or less Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Jordan Loftis his heirs and assigns forever. And I do hereby bind myself, my heirs, executors and administrators to warrant
