J. Jesse Meoon, of the State and District aforesaid, for and in consideration
of the sum of Three hundred and twenty-five Dollars paid by John M. Curston
of the State and District aforesaid, have granted, bargained and sold and
by these presents do grant, bargain and sell to John M. Curston One hun-
dred and thirty-eight acres of Land more or less lying in said District
on a branch of the Reedy Fork of Reedy being part of a tract of Land
granted to Cadwalader Jones assigned by his Excellency Thomas Pinckney
on the third day of December 1787 Also a part of a tract of land grant-
ed to Robert Gillam and assigned by his Excellency Thomas Pinckney on
the seventh day of April 1788.

The said One hundred and thirty-eight acres of land more or less laid
out to the said John M. Curston as follows Beginning on a pine 3 x on
James Creamer's land near Jesse Meoons thence N. 55 W. 9 chain to a
post oak 3 x thence N. 33 E. 15.25 chains to a post oak 3 x thence N. 38 W. 55
ch. to a stake 3 x on Samuel Tolling's land near A. H. Curston thence
N. 28 E. 9.50 ch. to a post oak 3 x on said line thence S. 62 E. 53 to a
