Vaughan of the District and State aforesaid in consideration of the  
 sum of five Hundred dollars to me in hand paid by Robert Van-  
 ghan of the District and State aforesaid, do grant, bargain sell  
 and release unto the said Robert Vaughan a certain planta-  
 tion or tract of Land containing one hundred acres more or less  
 Lying in Greenville District on Brushy Creek waters of Enoree  
 River and hath such boundrys, whereas beginning on a Holly  
 Bush on the Creek xiii running N 25 to a Populer Corner xiii S  
 70 1/2 W 28 to a stake corner xiii N. 3 1/2 W 190 to a stake xiii S  
 70 1/2 W 3200 to a stake by an oak xiii on a branch down sd  
 Branch to brushy Creek along sd creek to the beginning Corner  
 it being a part of a tract of Land originally granted to  
 Isaac Morgan all that here described the premises together also  
 another Tract or parcel of Land containing five acres lying  
 on sd waters bounded on the East side of the first described  
 Tract of Land and hath such boundree whereas beginning on  
 a stake on Rains line on a branch from thence down sd  
 Branch to a stake corner on Rains line thence along sd  
 line to Wests Spring Branch to a stake thence up sd branch  
 to a poplar from thence a straight line to the beginning it be-  
 ing a part of a tract of Land origially granted to Aaron  
 Kemp and Paul abner grants bearing date January the 1<sup>st</sup>  
 1785 and January the 5<sup>th</sup> 1795 in the whole one Hundred  
 and five acres all that here describe the premises together  
 with all and singular the rights members Hereditaments &  
 appurtenances to the sd premises belonging or in any wise in-  
 cident, or appertaining to have and to holde, all and singu-  
 lar the premises before mentioned unto the sd Robert Vaughan  
 his heirs and assigns for ever and I the sd Hannah Vaughan  
 do hereby bind myself my heirs Executors & Adm<sup>rs</sup> to warrant  
 & forever defend all and singular the sd premises unto the sd  
 Robert Vaughan his heirs & assigns against myself and my heirs  
 & against every person whomsoever lawfully claiming or to claim  
 the same or any part thereof Witness my hand and seal this  
 the 24<sup>th</sup> day of October 1845 Signed seals in the pre-
