W. M. Goodlett To 189 William West	Deed 953 Acres.

South Carolina I now do now
Greenville District. I by these pres-
ents, That I William M. Goodlett of
Greenville District in the State aforesaid,

for and in consideration of the sum of Nine Hundred and sixty
five Dollars to me paid by William West of Greenville District,
in the State aforesaid, I have granted, bargained, sold and re-
leased, and by these presents do grant, bargain, sell and release,
unto the said William West all that piece parcel and tract of
land, situate in the District of Greenville in the said State lying
on both sides of Mill Branch waters of the North fork of Saluda
River and bounded as follows Beginning on a W.C. corner of
Wm. Bates land and running thence along said Bates line S 29
W. 30c. 50L. to a Pine 3x thence S 24 W. on said Bates line till
it intersects John Moores line, thence or west course with said
Moores line 29c. 75L to a Pine 3x on Roy McCloys line, thence
N. 60 W. 9c. 50L. to a stake 3x said McCloys corner thence N.
86 W. along said McCloys line to a Red Oak corner made for
Anderson Sheppard, thence along said Sheppards line NW 8c. to
a Red Oak, 3x, thence N. 50 E. 20c to a maple 3x at a branch,
thence N. 74 E. 40c. to a poplar 3x thence NW 45 E. 44 c 50L.
to McCarrolls line thence along McCarrolls line N. 48 E 9c. 50L.
to the beginning W.C. containing Two hundred and fifty three
acres more or less.

Together with all and singular the Rights, Mem-
bers, Hereditaments and Appurtenances to the said Premises belong-
ing, or in anywise incident or appertaining: To have and
to hold, all and singular the Premises before mentioned unto
the said William West his Heirs and Assigns forever. And I do
hereby bind myself my Heirs, Executors and Administrators to
warrant and forever defend all and singular the said Prem-
ises, unto the said William West his Heirs and Assigns, w-
against me and my Heirs, and against every person whom so-
ever, lawfully claiming or to claim the same, or any part thereof.
