lease, unto the said William B. Jones all that tract or plan-  
tation of land containing 138 acres (more or less) Situate in Green-  
ville District on the waters of Enoree River. Beginning on a Rock  
3x3x or Nathan Paris land Thence on lands of Robert Blakely N.  
48 $\frac{1}{2}$  E. 26.18 to a Rock 3x3x Thence on said Blakely's lines N 88 $\frac{1}{2}$   
E. 15.00 to a Rock 3x3x Thence N. 23.10 to a Rock on John Bald-  
win's line Thence on said line N. 40 W. 30.93 to a Hickory 3x3x  
on Bank of Branch Thence on W. E. Cunningham's lines S 46 W.
