Know all men by these presents, That I Henry Paris now of Anderson and late of Greenville District in the State aforesaid, in consideration of the sum of Seven hundred dollars to me paid by Rachel Thomas of Greenville in the State aforesaid, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Rachel Thomas all that tract or parcel of Land situate lying and being in the district of Greenville and state aforesaid being the tract of Land on which I formerly resided and containing four hundred and thirty acres more or less & lying on waters of Saluda River, commencing at a post oak at the head of a branch known of Mrs. Thomas Land and running thence S 76 E 16.50 to poplar stump at the ford of the branch thence down the meanders of the said branch to a white oak corner on the bank of the said branch thence leaving the branch and running S. 15 W. 29 ch. to a post oak thence S. 20.16 to a Lt wood stake by a Red oak thence N. 70 W. 18 to Iron wood corner by old still House or a small branch, thence down the meanders of the said branch to its junction with the larger branch or Creek, thence down the said Creek to a stump corner near an old mill site, thence S ch 50 links to a chestnut corner, thence North 70 W 31 ch to a Hickory thence N. 34 E. 7.50 to a chestnut on another large branch or creek, thence up the meanders of the said Creek to the fork of the still House branch, thence up the said branch to the beginning corner, bounded on the north by Thomas & Pinsett's land, West by Thomas land and Watsons & Smith by Mrs Thomas & Stones land and both farm & maps according to a plat of John Young made 1805

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining: To have and to hold, all and singular the Premises before mentioned, unto the said Rachel Thomas her Heirs and Assigns forever. And I do hereby bind myself & my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said Premises, unto the said Rachel Thomas Heirs and Assigns, against me and my Heirs, and against every person whomsoever, lawfully claiming or to claim the same, or any part thereof.
