Beginning on a White Oak x near a Branch. Thence East to a Red Oak x on the Road leading to H. F. Silvaths. Miles, Thence N. E. along said Road to a Chesnut x Thence S. W. to a Stake x Thence West to a Post Oak x Thence to the beginning corner.

To have and to hold all and Singular the rights, Members, Hereditaments, and appurtenances in any wise belonging or incident thereto unto and do hereunto for ever defend the said Premises unto the said A. W. Glenn his heirs and assigns against myself my heirs and assigns and against any person or persons Lawfully Claiming the same or any part thereof.
