One Hundred and Twenty six Dollars sixty one half cents payable to Jesse Carter the
on demand now know you that I Emmanuel Lindsey for the better securing the pay-
ment of the sd sum of One Hundred Twenty six Dollars sixty one half cents to the
said Jesse Carter his heirs, Executors, Administrators or assigns, together with the lawful
Interest for the same I have here bargained sold & by these presents do bargain and sell
& release unto open Market deliver unto the sd Jesse Carter all my tract of Land wherein
I now live containing seventy acres more or less being lands all around of the sd Jesse
Carter lying on the waters of south hole of Big river Dog, but with all the appurtenances
thereunto belonging or appertaining to the same I do now & hold the said tract of
land above named unto the sd Jesse Carter his heirs, Executors, Administrators & assigns
free. Provided always nevertheless that that if the Emmanuel Lindsey a his heirs, Executors
or administrators shall and do well & truly pay a sum to be paid unto the sd Jesse Carter
or his certain attorney Executrix, Administrator or assign the full and just sum of One
Hundred and Twenty six Dollars sixty one half cents, according to the true intent &
meaning of the party of these presents together with the lawful Interest now or before the
25th March 1848 given this deed of bargain & sale and all and every claim, article and
thing herein contained shall close determined it to be utterly void and of none effect
and thing herein contained to the contrary though in any wise notwithstanding and it is hereby
declared by & between the sd parties & the sd Lindsey his heirs, Executors, Administrators &
assigns fully covenant promise and agree to & with the sd Jesse Carter his Executors
Administrators & assigns by these presents that if default shall happen to be made of or
non payment of the sum of One Hundred and Twenty six Dollars sixty one half cents as
aforesaid according to the true intent and meaning of the parties here to that that in such
case it shall and may be lawful to and for the sd Jesse Carter his Executors, Administrators
attorneys & agent from time to time at all times hereafter peaceably and quietly to enter
into any or all the aforesaid lands or tenements of the said Lindsey and to take the same
mentioned into his custody & possession & the same to hold and detain to his own use &
benefit as his own Land and Tenement from thence forth forever or the same to
such dispose of at will and pleasure returning the aforesaid if any should happen
to be after paying the said sum of One Hundred and Twenty six Dollars sixty one
half cents in trust unto the said Jesse Carter, Executrix, Administrators or assigns.
