 running thence N 34 W 39 to a Stake, Thence S. 48 W 26 to a Stake Thence N 46
 W 36 to a Black oak sapling, Thence N 30 E 24. 43 to a Stake, Thence S. 53 E 44. 75
 to a Stake, Thence N 34 E. 7. 84 to a black oak, Thence South 35 E. 27. 38 to a
 Stake, Thence S. 28 W. 16 to an ash on a small branch, Thence South the said branch
 to the beginning, maps &c. being the same tract conveyed by deed dated 9th
 January 1843. by Thomas Ferguson Sr. to Thomas Ferguson Jr.

 of conveyance and trust to make and constitute the said Smith Brady a lawful
 and sufficient attorney at any and all times when he may be called on to do, by my
 mother the said Mary Ferguson to make such deed to part or parts of
 said premises or the whole of the same, to any person or persons, the said Mary Fergu-
 -son may name. In witness whereof the present and future disposal of the same
 without let or hindrance, intefairness or contrary dictation or modulation from any
 person whatsoever, and especially from her husband and my father Thomas Ferguson
 Sr.
