Have granted, bargained, sold released and conveyed and by these presents do grant bargain, sell release, and convey unto the said Thomas M. Cox a certain piece or parcel of Land situated in the State and District aforesaid about one half of a mile from the village of Greenville between the roads leading to Augusta and Pendleton Beginning at a Stake 3X on the Pendleton road Jesse Dean's corner and running thence with said road S 67° W 28 poles to links to a line in said road thence S 66° W 53 poles 19 links to a Stake 3X E S. S. corner in said road thence with said S. S. line S 18° E 25 poles to a Stake 3X thence with said S. S. line S 16° W 6 poles 6 Links to a small sweet gum 3X thence S 18° E with Sandy Walker line 12 poles to a B. Oak 3X near a Stake thence with said Walker line N 78° E 59 poles to a B. Oak thence thence N 8° E with said Walker line 18 poles to a Stake in the Augusta Road thence N 39° W 2 1/2 poles to a B. Oak stump formerly, now gone, thence with said road N 27° E 40 poles to a B.
