Tally the wife of James Tally and Martha Hutchings the wife of Samuel  
Hutchings did this day appear before me and upon being separately and separately  
examined by me did declare that at least seven days previous to this examination  
they did actually join their husbands in a Deed of Attorney to Thornton P Pool  
authorizing and empowering him to sell and convey three certain tracts of  
land in Greenville District of South Carolina of which Peter P Peacock  
did seize and possess consisting of First the Home Tract supposed to con-  
tain about one Hundred and Twenty five acres Second the Fox Branch tract  
containing One hundred and thirty five acres more or less Third the  
Pacholite Tract containing Three hundred and Sixty acres more or less  
and they did at the time of the Execution of the said deed of Attorney and  
still do freely voluntarily and without any compulsion dread or fear of  
any person or persons whomsoever renounce release and forever discharge all  
her Estate interest and inheritance in the said Tracts of Land unto the  
Grantee or Grantees of the said Thornton P Pool by Virtue of said Deed of Attorney  
was positively and bona fide executed at least seven days before this exami-  
nation Seven under my hand and seal this day of December 1848

in the State and District aforesaid on both sides of the Augusta road bounded on the South  
and West by lands belonging to H G Peterson on the East by lands belonging to S C  
Sullivan on the North by lands belonging to Nancy Gaines and Jonathan Deveece The other  
tract containing Sixty Acres, more or less, situated in the State and District aforesaid bounded  
on the South by lands belonging to H G Johnson on the East by lands belonging to S H Sh-  
anahan on the North by lands belonging to S C Sullivan Together with all and singular  
the rights, members, hereditaments and appurtenances to the same belonging or in anywise incident  
or appertaining To have and to hold all and singular the said premises unto the said  
I R Smith his heirs and assigns forever And I do hereby bind myself my heirs  
executors and administrators to warrant and forever defend all and singular the  
premises above mentioned unto the said I R Smith his heirs and assigns against
