Dollars to me paid by James A. Mc Carter of the same State and District have  
 granted, Bargained, sold and released and by these presents do grant bargain sell  
 and release unto the said James A. Mc Carter his heirs and assigns forever  
 a certain Tract of Land containing Ten and a half Acres Situated in said  
 District on the Spartanburgh road near the late Residence of Capt Isaac  
 Green, Deceased, it being part of a Tract of Land originally granted to  
 Samuel James Alston and conveyed by part of the heirs of Matthew Waddell  
 deceased to Jacob Green and from Jacob Green to myself Phoebe Green and  
 hath such bounds &c. as follows Viz Beginning at a Stake 3X on the said  
 road near the old crop road on one of the original lines of said Grant thence  
 along the Spartanburgh road So 89° 2' 12.50 E to a white oak sapling on said road
