

do grant bargain sell and release unto the said Oliver Barrett his heirs and assigns all that Tract a parcel of Land lying and being situated in the District aforesaid on the North Fork of Saluda River bounded by the River and Lands of William Bates and others known as the tract purchased by Susan McCay from William Choice Commissioner in Equity and part of a Survey Originally granted to William McCollum containing Two Hundred Acres more or less Together with all all and singular the Rights members hereditaments and appurtenances thereunto belonging or in any wise appertaining To have and to hold his heirs and assigns forever and I do bind myself my heirs and assigns to warrant and defend unto the the said Oliver Barrett his heirs and assigns against myself my heirs and assigns and against all other persons lawfully claiming or to claim the same or any part thereof.

Now know ye that the conditions of the above deed Mortgage and conveyance is such that if the said Roy McCay do well and truly pay or cause to be paid unto the said Oliver Barrett Executrix of the Estate of Susan McCay the sum of a certain note of hand a single bill given by the said Roy McCay Endorsed by T J Wharrell as security to Robert Lee et al of the Executors of the Estate of Susan McCay then for the sum of Seven hundred and ninety nine Dollars the twelve months after date and dated the 15th of November 1847 being the amount of said Roy McCay bid for said tract of Land. Then and in that case the above Deed Mortgage and Conveyance to be null and void and of no effect, otherwise to stand in full force and virtue and to hold good both in law and Equity.
