District and state aforesaid. send greeting

Wheras by virtue of a Writ of Fieri Facias issued out of the Court of Common
Pleas held for the District of Greenville last the seventeenth day of August in
the year of our Lord One Thousand eight hundred and forty one at the suit of W H C
Watson to me directed commanding me that of the Goods and chattels, lands and tenements
of Sabid Bradley to pay the sum of Forty Dollars damage and costs I have seized
and taken of the same and tenements of the said Sabid Bradley Fifty acres more or less
situated and being in the District of Greenville lying on the head waters Tiger adjoining
lands of J. McKinney, W W Goodlitt and others.

This Wheras the said premises with their appurtenances since
the seizure of me made by virtue of the said Writ of Fieri Facias before mentioned have been
offered to sale at public vendue and purchased by W H C Watson of the District of Greenville
for the sum of Seventy Five Dollars being the highest that was bidder therefor
Now I bind by that I Massena Taylor Sheriff aforesaid by virtue of said Writ
of Fieri Facias aforesaid to me directed are delivered as aforesaid and by virtue
of the Statute in such cases made and provided and for and in consideration
of the sum of Seventy Five Dollars to me in hand paid or secured to be paid
by the said W H C Watson the receipt and payment whereof I do hereby acknowledge have
granted bargained and sold and by these presents do grant, bargain and sell
unto the said W H C Watson his heirs and assigns forever the said tract piece or parcel
of land with its appurtenances and all the estate right title and interest which the
the said Sabid Bradley of right had or in or to the same

To have and to hold the said piece, parcel and tract of land with its
appurtenances unto the said W H C Watson his heirs and assigns forever as fully and
absolutely as I the said Massena Taylor might or ought to grant, bargain
and sell the same by virtue of the Statute aforesaid and the said Writ of Fieri Facias
or otherwise.

In witness whereof I the said Massena Taylor have hereunto set
my hand and seal the nineteenth day of December in the year of our Lord One
Thousand Eight Hundred and Forty eight.
