Granted Bargain sold and released and by these presents do grant, bargain  
Sell and release and convey unto the said Benjamin Yerger all that tract  
or parcel of Land situated in the District and State aforesaid on the water  
of the Bridge Fork creek waters of the Cheeche River Binding on Land  
of Elizabeth Parkins, Rob Bramlett, Solomon Holland, Josiah Briscoe  
Containing One Hundred and two acres more or less and also doth, bargain and  
sell in Captain and open market value unto the said Benjamin Yerger  
of the State and District aforesaid the following property - Eighty  
one more, a bay 3 Years Old, and one yoke and two oxen and by further  
Sixteen Pecks of hog and my present year crop of Corn, fodder, cotton and  
oats To have and to hold all and singular the premises and personal  
estate above mentioned unto the said Benjamin Yerger his heirs and assigns  
forever, provided nevertheless and upon conditions that if the said Wade Smith  
his heirs and executors and administrators shall well and truly pay a cause to  
be paid unto the said Benjamin Yerger his certain attorney executors, adminis-  
trators or assigns the full and just sum of One Hundred and Fifty Dollars  
and sixty one cents on the first day of April next at my house with legal  
and lawful interest. Then and in such case and at all and from all times  
hence forth these presents and all the Estate both real and personal hereby  
granted and every article clause and sentence herein contained shall cease  
to determine and be utterly void to all intents and purposes any thing herein contained  
to the contrary notwithstanding this the 17<sup>th</sup> day of March A.D. 1849 in the seventh
