by virtue of Writs of Free Passes issued out of the Court of Common Pleas held
for the District of Greenville First the Thirteenth day of April in the year of
Our Lord One Thousand Eight Hundred and forty Nine at the town of
Valley Mc Bee and others to me directed commanding me that of the goods and
chattels lands and tenements of Mr L Pollard to levy the sum of Forty Two
Dollars and 28 cents damage and costs I have seized and taken of the lands
and tenements of the said Mr L Pollard all that certain piece parcel or tract of
land containing one acre more or less situated and being in the District of Greenville
lying on Valley River adjoining lands of Mr Bains. Mayfield and others

And Whereas the said premises with their appurtenances since the saying
of me made by virtue of the said Writ of Free Passes before mentioned have been offered
to sale at public vendue and purchased by David Heoke of the District and State
aforesaid for the sum of Three hundred and Seventy five dollars being the highest
sum that was bid therin Now know ye That I Massassen Taylor
Sheriff aforesaid by virtue of the said Writs of Free Passes aforesaid to me directed
and delivered as aforesaid and by virtue of the Statute in such cases made
and provided and for and in consideration of the sum of Three hundred and
Seventy five dollars to me in hand paid or secured to be paid by the said David
Heoke the receipt and payment whereof I do hereby acknowledge have made
bargained and sold and by these presents do grant bargain and sell unto the
said David Heoke his heirs and assigns forever the said tract piece and part
of land with its appurtenances and all the estate right title and interest which the
said Mr L Pollard of right had of in and to the same

To have and to hold the said piece parcel and tract of land with
its appurtenances unto the said David Heoke his heirs and assigns forever
as fully and absolutely as I the said Massassen Taylor Sheriff aforesaid
