sold and released and by these presents do grant bargain sell and release unto
the said Oliver Barnett all that Tract a parcel of Land situated lying and being
in Greenville District on South the Tugoo River Containing One Hundred and fifty
Acres more or less Bounded by lands of Oliver Barnett Josephine Charlotte and Pompe
McMillen and the river being a Tract of Land lying & tract of Land which Oliver
Oliver Barnett purchased of the Ordinary's sale of the same for division amongst the
Heirs at law of David Dunahoo and recently in dispute in the Court of Common Pleas
between the said Oliver Barnett and Jordan Poole under a purchase from Sally
Poole Together with all and singular the Rights Members, Hereditaments
and Appurtenances to the said Premises belonging or in any wise incident or appur-
tenant To Have and to Hold all and singular the premises before mentioned unto
the said Oliver Barnett his Heirs and Assigns forever

And I do hereby bind myself my Heirs Executors and Administrators to warrant and forever defend all and singular the said Premises unto
the said Oliver Barnett his Heirs and Assigns against me and my Heirs
and all others lawfully claiming the same or any part thereof
