 love and kindness which I have and do bear

for my two sons Richard H. Jacobs and Edward C. Jacobs and also in consideration
 of the sum of Five Dollars to me paid by the said Richard H. and Edward C. Jacobs
 have granted bargained sold and released and by these presents do grant bargain
 sell and release unto the said Richard H. Jacobs and Edward C. Jacobs to be their
 joint property a certain tract of Land containing Six hundred and Sixty one acy
 be the same more or less situated in the district and State aforesaid on Bushy
 Creek of Needy River in being part of a Tract of Land of eight hundred and
 sixty one acy I purchased of Baylis, I Earle and know by the name of the Roarke
 tract The part now to be conveyed has such bounds more or less as follows Beginning
 at the mouth of a branch on said Bushy Creek at the upper end of the part of said
 Roarke Tract I conveyed to my son John Jacobs Thence up the meander of
 said branch about 12 chs to a Stake corner of said John Jacobs land Thence
 S 37 E 50 chs to a Stake corner Thence S 40 W 17 chs to a Stake 3x Thence N 45 W 17 20
 chs to a P. O. 3x Thence due west 57 80 chs to a red oak 3x Thence N 16 E 65 chs to
 a Pine 3x Thence N 20 E 34 50 to a Red oak 3x Thence N W E to a Stake 3x
 on the said Bushy Creek Thence down the meander of said Creek to the beginning
 corner, it being part of a Tract of Land granted to Page Roarke part of an other grant
 to Charles Castice and the whole of a Grant made to Polly Lewis, the whole of the said
 Roarke place including a small vacant piece was regranted to the said Baylis
 & Earle Together with all and singular the rights, liberties, tenements & can
 appurtenances to the said premises belonging or in anywise incident or appertaining
