 by John S. Bullow of Charleston South Carolina Situated in the District and State aforesaid  
 on the North side of Reddy River or Maple Creek waters of said River adjoining

 And I have now arrived at lawful age I do give grant sell and release all my right  
 title and interest as an heir and legatee of my Mother Patsy Potts (to whom said Deed was
