that I Wm. Bramlett of Greenville District and State aforesaid for and in consideration of the sum of One hundred and twenty dollars to me in hand paid by Sosiah Bramlett of the District and State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Sosiah Bramlett a plantation or tract of Land lying and being situated in the District and State aforesaid on north side of Bridge Fork of Tidley Creek waters of Conestee River it being a part of a Tract Originally granted to William Gamble by his Excellency William Montague the first day of December 1794 The Lands to be conveyed beginning on a stake 3^{ft} S 15° E 14^{ft} to stump and bush 3^{ft} in Peter Forks. going thence with the various meanders of said creek to my spring branch on a Stake 3^{ft} S 70° W 30^{ft} to beginning including first Acre being the same more or less Together with all and singular the rights, members, tenements and appurtenances to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Sosiah Bramlett and I do hereby bind myself and my heirs Executors and Administrators to warrant and forever defend all and singular the premises before mentioned unto the said Sosiah Bramlett his heirs and against every other person whomsoever claiming or to claim the same or any part thereof.
