 S 76 W 16.50 to a H oak 3x then the Head Thence with the Head to a Post 3x 3x Thence
 N 61 W 25.50 to a H oak 3x Thence S 30 W 25.75 to a H oak 3x Thence S 36
 E. 49 to a Stake 3x at the corner of Lot No 2 Thence S. 86. E a straight line to the beginning
 corner including the dwelling House in which the late Col. William Byrnes deceased
 did live it being the same tract of Land that William Chance as Commissioner
 in Equity for Greenville District conveyed to Samuel B White by deed bearing date
 the 3rd day of December 1829 and conveyed to Daniel Wallace by said White by
 deed bearing date 10th day of February 1832 and conveyed to Thomas Byrnes by
 Daniel Wallace by deed bearing date 18th November 1833 and conveyed to
 William Goldsmith by Thomas Byrnes by deed bearing date 18th January
 1834 and conveyed to Thomas Goldsmith by William Goldsmith by deed bearing
 date the 21st day of November 1839 and conveyed by Thomas Goldsmith to
 William Goldsmith by deed bearing date the 6th day of November 1841

 my heirs and against all persons whomsoever lawfully claiming a to claim
 or any part thereof Given under my hand and Seal this 6th day of November
 in the year of Our Lord One thousand Eight hundred and forty one and in the 66th yr.
 of the Independence of the United States of America
