Mc Roberts deceased and in pursuance of the power and authority vested in us by the last will and Testament of the said John Mc Roberts deceased late of Greenville District in the State aforesaid for and in consideration of the sum of Three Thousand Dollars to us paid by Waddy Thompson of Greenville District in the State aforesaid have granted bargain - since sold and released and by these presents do grant bargain sell and release unto the said Waddy Thompson All that piece parcel and Tract of Land of which the said John Mc Roberts deceased did seize and possessed containing One Hundred and forty Nine Acres more or less situated lying and being in the District and State aforesaid on Richland Creek waters of Rich River bounded by Lands of Gen. Waddy Thompson Rev. C. J. Buist West C. D. Stone, W. Choice & J. M. Handolph and being composed of Five Tracts of Land one containing Sixty One Acres conveyed to the said John Mc Roberts, dec'd. by deed bearing date the 26th November 1835 the other containing eighty eight acres conveyed to the said John Mc Roberts by Waddy Thompson & dec'd bearing date the 18th August 1840 and having such courses courses and distances as are set forth in a plat of the same made by a survey by John Watson Esq deputy Surveyor the 18th August 1840 which is truly recognized as a description of the said Land Reserving and excepting of the said Land about three fourths of an acre lying on the East side of the Spartanburg Road which has heretofore been sold and conveyed by the said John Mc Roberts deceased in his life time to Rev. C. J. Buist
