Jacob Ballou To Fostina Pitman	Dec'd 16 th March	State of South Carolina & "Know all men of Greenville District } by these presents that I Jacob Ballou son of the State and Dec'd trust aforesaid for and in consideration of the sum of One Hundred Dollars to me in hand paid by Fostina Pitman of the District and State aforesaid the receipt and payment whereof I hereby acknowledge, I do grant to Fostina Sette and convey unto the said Fostina Pitman his heirs and assigns a certain Tract a parcel of Land Situated in the District and State aforesaid on the Brushy Fork Branch and Green Creek being head waters of Packetel Head Beginning at the Brushy Fork Branch on the Original East line and running South with the same to a fallen Red Oak Thence N 65° W 15 ch. to a Spanish Thence S 64° W 15 chs to a Locust Thence S 65° W 5 chs to a State Thence N 45° 15 chs to a Spanish oak Thence S 35° W 10 chs to a Red Oak Thence Eastward with Reason Ballou line to the Brushy Fork Thence down branch to the River to the big containing by estimation One Hundred and Sixty Acres to the same more or less Together with all and singular the Rights Privileges tenements and appurtenances belonging to the same or in any wise incident thereto pertaining to it & the said Jacob Ballou for myself my heirs executors administrators and assigns. Warrant and power defend the above mentioned premises unto the said Fostina Pitman his heirs executors administrators and assigns for and against myself my heirs and assigns for and against every other person a person whomsoever being having the same or any part thereof.
