year containing five Acres more or less Beginning on a Stone 37m Thence N
82 1/2 W 1.90 chains to Pine 37m Thence N 53 1/2 W 4.49 chains to a Red oak 37m
Thence N 78 1/4 W 4.49 chains to a Chestnut 37m Thence S 34 W 2.4 chains to a Red
oak 37m Thence S 49 E 11.14 to a Sycamore 37m Thence N 49 E 6m to the beg-
inning Rock together with all and singular the rights members incidents tenements
and appurtenances thereto belonging or in anywise incident or appertaining

unto the said Erwin Green his heirs and assigns forever and I do hereby bind myself
my heirs Executors and Administrators to warrant and forever defend the above men-
tioned premises unto the said Erwin Green his heirs and assigns against myself and
