of South Carolina and District of Greenville and Spartanburgh said Lands being  
in several parcels or Tracts one of which contains Two Thousand Two Hundred and  
Sixty eight Acre Situated on Holston Creek so called in Spartanburgh District  
and other Tract adjoining the above containing 4893 acres Granted to C M  
Gaulthard and on other tract on Birds Creek so called on the Howards Gap road  
containing 300 Acres more or less; one other Tract containing 445 acres Situated  
in said District of Spartanburgh near Birds Mountain so called and another tract
