County in the District aforesaid and bounded on the West by W. S. Johnson
and one Nancy Smith's land North East by Harmon Waldrop's land South East by
James Johnson and Samuel Charles Lane and that such shapes and marks as is here
set out by a plat herewith annexed made out by J. M. Clontar being by estimation
Handred Acres in Woods 1849 was a copy

Together with all and singular the rights members Hereditaments
and appurtenances to the said premises belonging or in anywise incident or appertaining
to the same. And to hold all and singular the premises herein mentioned
unto the said Dagley Finley his heirs and assigns forever and I do hereby bind myself my heirs
executors administrators to warrant and forever defend all and singular the said premises
the said Dagley Finley his heirs and assigns against myself and against every person or
persons lawfully claiming or to claim the same or any part thereof as witness my hand
and seal this 26th day of August 1849
