Henry Mc Earle my release and my present to grant him a full and release  
unto the said Henry Mc Earle All that lot a parcel of Land situated being  
the 18th day of May 1851 lying in Greenville District one State acre on the western side of the Washington  
Highway about one and one half miles from Greenville Court House containing One acre  
fully described more or less commencing at a Stake called "The Gun" and running  
to the N.E. A post set in a Stake on the boundaries line between said lot to the State  
line said Stake is about 80 links along said line to a Stake. There is a road  
in the beginning run over Grade such farms and roads as a part of the same made  
by Mr. Mc Earle before his removal. In trust to the said Henry Mc Earle for  
use of my son daughter Mrs Sophia Earle and the children of the said Sophia  
Earle and the said Henry Mc Earle during my life and after my death with all  
and his heirs and assigns forever.

Together with all and singular the Rights Members, Shares  
and Appurtenances to the said Property belonging or in anywise incident  
pertaining to have and to hold all and singular the Premises before me  
aforesaid come unto the said Henry Mc Earle during my life for the use and benefit of  
the said Sophia Earle and the children of the said Sophia and said Henry Earle  
and past and after my death absolutely and in fee simple unto the said Henry Mc Earle and  
his heirs and assigns forever More I do hereby bind myself and my executors  
and Administrators to warrant and forever defend all and singular the said  
Property unto the said Henry Mc Earle in the way and manner aforesaid to him and  
to his heirs and assigns against me and my heirs and against every person  
that may claim the same or any part thereof

Year of our Lord One thousand eight hundred and fifty one in the County  
of Greenville State of the Independence of the United States of America
