his daughter and contains 41 1/4 acres more or less Beginning at the River on the right hand
there to a continual course thence with a conditional line between Mary Sallie and the
Mister Sallie to the River thence with the River to the beginning And we do hereby bind ourselves
selves and heirs and assigns to warrant and defend the above described premises unto
the said Sach Sallie his heirs and assigns of whom ever they may be and every other person lawfully claiming the same
