 I have all seen by these presents
 that I Stacy Chapman
 of the District and State aforesaid
 and in consideration
 of the natural love and affection which I have and have
 had for my son Carter Chapman and in consideration of the sum of Two Hundred

and ten dollars to me paid by him said Carter Chapman of Guilford District in the
 State aforesaid have granted bargained sold and released and by these presents do grant
 bargain sell and release unto the said Carter Chapman All That Tract a parcel
 of Land Situated and lying in the District of Guilford aforesaid on Mountain creek
 near the Saluda River containing Twenty Acres more or less Commencing on
 Post Oaks and running thence N 85 E 4 1/2 a stake capping Mountain creek Thence
 S 20 W 26 1/2 a stake S 8 Thence S 85 W 17 1/2 again capping the creek to a stake Thence
 N 15 W 3 1/2 a stake Thence S 85 W 18 1/2 to a stake Thence W 20 N 16 1/2 to the beginning
 and having such form marks and bounds as are represented by a Mark Trees situated
 among Mr Samuel Mc ever at S Sept 27, 1814 to wit in the said Carter Chapman
 in fee simple after my death and I do hereby reserve to myself the possession use and en-
 joyment of said land for and during my natural life having covenanted and agreeing
 the said Carter Chapman to stand seized of the life estate in said Land to the intent that
 may have and enjoy the absolute fee simple in the same at the termination of the life e-
 state reserved by this deed

Together with all and singular the Rights Appurtenant thereto
 and Appurtenances to the said Premises belonging in anywise incident or appurtenant

To have and to hold all and singular the Premises together with
 and unto the said Carter Chapman after my death to him and his heirs and assigns
 forever And I do hereby give myself and my heirs Executors and Administrators to
 and our former depts all and singular the said Premises unto the said Carter
 Chapman his heirs and assigns against me and my heirs and against every
 one whomsoever lawfully claiming a right claim the same or any part thereof

 the Independence of the United States of America
