granted, bargained, sold and released and by these presents do grant, bargain, sell and
release unto the said Thanton P Poole all and singular my right title interest, claim and
estate of in or to a certain tract or parcel of land Situated in Greenville District
the State of South Carolina on both sides of Panthers Fork of Muske Creek and
of Tyee River Containing One Hundred and Sixty Two acres more or less being
as follows, beginning on a White Oak Tree known and Thence 305 feet by chains
to Sinks to a Spanish Oak Thence 320 E 33 chains to a Red Oak Thence thence 300
70 chains to Salmon's back line Thence 3065 ft to a Red Oak Thence the various
courses of said line to the beginning the same being part of a tract of Fifteen hundred
and forty acres granted to George Salmon the 3d day of April 1787

Together with all and singular the rights members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining
To have and to hold all and singular the premises before mentioned
unto the said Thanton P Poole his heirs and assigns forever.

And I do hereby bind myself my heirs executors and administrators forever
to warrant and forever defend all and singular my right title interest claim and
estate in the said premises unto the said Thanton P Poole his heirs and assigns again
me and my heirs and against every other person lawfully claiming a to claim the same or to
any part thereof.
