of the District and State aforesaid and in consideration  
of the love and affection I bear unto my

daughter Mary Center wife of Jefferson Center aforesaid and in consideration of the sum  
of one dollar to me in hand paid by Wm. Ballou of the District and State aforesaid  
receipt whereof I hereby acknowledge Name Bargainer sold and conveyed and by these pres-  
ents do Bargain sell and convey unto the said Wm. Ballou a certain Tract of land  
parcel of Land Situate lying and being in the District and State aforesaid on the side  
Bank of Sycamore River being the same Tract I lately purchased from Jefferson Center and  
wife Mary Center under deed bearing date Decr. 23<sup>rd</sup> 1850 containing Two Acre  
and three fourths acres more or less Beginning at the river on the Original line there to a  
white oak tree \$58 & 24cts Recd. Stone to a cordial corner between Mary  
Ballou and Wm. Ballou to the River Stone up the River to the Beginning

Say this with all and singular the rights messengers heredetments and  
appertaining to the same belonging or in anywise incident or appertaining to the said  
Wm. Ballou To have and to hold all and singular the premises above mentioned  
unto the said Wm. Ballou quamcumque upon the special Trust and confidence mentioned  
and to and for the several uses intentions and purposes hereinafter mentioned and declared  
and for no other purpose use or intent whatever That is to say In Trust to permit and to  
suffer the said Mary Center To have and to hold possess and enjoy and to appropriate the proceeds  
of the above mentioned premises in my manner she may think best for the support of herself  
and family without influence of any person whatsoever and without being to the present or future  
creditors of the said Jefferson Center a yd of time of any future husband and in case she may die  
by and during the term of her natural life and at the death of the use and benefit of her  
widow or child as she may leave her surviving, then and shall make if now then one hundred  
she die leaving no child or children and the said husband surviving in that event the said said  
premises are to revert to my estate for the use of the same as my will may direct or shall be  
testate them to be applied in due course of administration

The possession of the said premises above mentioned by my daughter  
Mary Center during her life as aforesaid is not intended to effect in any manner the legal transfer  
of the said Wm. Ballou to the said premises which is fully vested in him for the use and benefit  
Trusts above dictated and set forth the Shanty my daughter Mary Center at any time hereopent  
disposed to resume from the above premises then and in that case the said Trustee shall have  
full and absolute power and authority to Revert the said Tract of Land and apply the same  
excess to the support and maintenance of my said daughter Mary Center
