and released and to these presents do grant to gain sell transfer and convey  
over to Elijah Esther his heirs and assigns all his right Title interest and in any  
stance which we have or make to a certain Tract of Land lying in Greenville Dis-  
trict on Sakey Creek in the County of Anderson containing One hundred and  
fifty Acres more or less being the Tract of Land of which the late George Smith had  
once seized and possessed and which passed to certain of his heirs by his last will and  
testament.

We have and to hold all and singular the said interest unto the said  
said Elijah Esther his heirs and assigns forever and we hereby bind ourselves to  
and swear to warrant and defend all and singular the said interest unto the said Elijah  
Esther his heirs and assigns by against ourselves and our heirs and assigns to  
every person claiming the same or any part thereof.

Greenville District affords a depository unto whom it may concern shall  
Polly Kelly wife of Isaiah Kelly and joint grantor of the within Land doth this day testify  
and before me and upon being privately and separately examined by me did declare to  
that Shadley Kelly voluntarily and without compulsion or dread or fear of any kind and  
persons whomsoever release and convey all her interest and right of inheritance  
to Elijah Esther his heirs and assigns forever unto all and singular the persons  
aforesaid mentioned and released.
