Coate beginning at a stake near said road running N 37 W 6.32 links to a stake near the said Head Thence S 37 W 35 links to a small P.O. Thence S 37 E 6.32 links to a small P.O. Gun, Thence N 33 E 3 links to the beginning also all that piece or parcel of land adjoining the above lot beginning at J.P. Butler's corner on the Turnpike road and running with said Head N 37 W 1.58 links to a stake Thence S 37 W 11.16 links to a stake Thence S 37 E 7.90 links to a stake Thence N 33 E 3.16 links to said J.P. Butler corner on a small P.O. Gun Thence with said J.P. Butler land N 37 W 6.32 links to a small P.O. Thence N 33 E 3.16 links to the beginning containing more or less to the same more or less comprising two conveyances the one from Varney M.P. to E.P. Jones and from E.P. Jones to J.P. Butler and the other from Varney M.P. to J.P. Butler

Butler Thompson his heirs and assigns against me and my Heirs and against every person whomsoever lawfully claiming or to claim the same in any part thereof
