James Calhoun of the State and District

to my day of birth in consideration of the sum of Ten Thousand and twenty dollars
to me paid by Andrew Ramsey of said State and District of South Carolina
granted, Bargained, Sold and Released and by these presents do Grant
Bargain sell and release unto the said Andrew Ramsey a Branch of Santee Bay
in The State and District aforesaid on the North Side of Reedy River con-
taining Five Hundred and eighty acres in the same manor as his
present dwelling at Branch of said River to myself, Newell Sullivan, and
set forth in part of my legal share of Estate and upon said S. Sullivan to said
Andrew Ramsey beginning on Reedy River on a red oak 34 W 6 N 10 E 1/2
acres 34 Thence running up Micaylly Survey from river to the
branch it crosses, say Poplar Bottom Branch and thence up said Branch
with its meanderings to the mouth of Branch called Nathan River Spring branch
and bounded on Maple Hill Thence up said spring Branch to a pale
creek in the fork of said Branch near a spring Thence S 32 E 48 Chars
1/2 acre Oct 10 a post oak creek Thence down said Creek S 45 E 26 N 1/2
acres Hickory 34 acres, Robert Bellings Land Thence W 58 E 30 N 75 to a
State 34 Thence S 35 W 25 E 1/2 a post oak 34 Thence S 70 E 12 N Red oak
dead and dead Thence S 56 E 1 1/4 N 50 to a post oak 34 Thence W 54 E 34 N 50

defend all and singular the said premises unto the said Andrew Ramsey
his heirs and assigns against myself and my heirs and against every person
who may claim or pretend to claim the same or any part thereof
