 said Sarah Heest the receipt whereof is truly acknowledged hath granted
 Bargained, Sold and Released and by these Presents doth Grant Bargain
 sell and Release unto the said Sarah Heest her heirs and assigns all
 that Tract and parcel of Land lying and being situate in the State and
 District aforesaid known and described by a recent survey made of
 same by Samuel Moore Deputy Surveyor on the 10th July 1833. as
 follows Beginning at Stone 34 old mark Thence N 13 E 5 1/4 Sullivans
 Gate Stone N 76 E S. 75 Stone Stone N 88 W 1/4 Stake a young
