that me, Samuel Raines a free coloured man and Robt B Duncan Guardian for the said Samuel Raines for and in consideration of the sum of six hundred and fifty dollars to us in hand paid by Emilia C Green. Have granted bargained, sold and released and by these presents do bargain grant, all and release unto the said Emilia C Green, a certain tract or parcel of Land situate in the district and state aforesaid on Canebriak branch waters of Enoree river, containing one hundred and thirty acres, the same being part of a tract of Land formerly owned by William Ayler & conveyed to him by Dudley Howell and by Dudley Howell to Thomas and by Thomas Howell to John Shockey and by the said Shockey to myself. Beginning on a Spanish oak 3x3 1/2 m. running S 1/4 N 3/4 W to a P.O. 3x0 m. thence S 79 E 18 7/8 ch to a stone, thence due south 11 3/4 to a stone, thence N 88 3/4 W 35 1/2 ch to a pine tree x new original stake, thence N 10 W 35 ch to a Maple 3x3 1/2 m. on the bank of branch, thence N 7 E 29 1/2 ch to a Pine tree x thence S 87 1/2 E 18 3/4 ch to the beginning. Together with all and singular the rights, members and hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises above mentioned unto the said Emilia C Green her heirs and assigns forever. I Samuel Raines do hereby bind myself, my heirs, Executors and administrators, to maintain and forever defend all and singular the said premises unto the said Emilia C Green her heirs and assigns, against myself, my heirs and every other person or persons lawfully claiming or to claim the same or any part thereof.
