use and consideration of the sum of five hundred and fifty dollars to me in hand paid
 by Benjamin F. Barton and Bayles W. Fleming, all parties of the State and
 district aforesaid, have engaged and sold unto the said Benjamin F. Barton
 and Bayles W. Fleming, a certain tract or parcel of land lying in the district
 aforesaid lying on the water of Tyger river, beginning on a red oak near the
 yard at Tyger river running N 10 to a shell hole, thence N 61 E 54, 99 to a stake
 thence N 30 W 54, to a red oak, thence S 76 W 17, 50 to a white oak, thence S 10 E 5
 thence S 44 E 31 to a small white oak thence S 46 W 39, 50 to the beginning, it being a
 of land granted to John Russell and also one other tract or parcel of land supposed to
 contain six acres conveyed from Thomas Barton to William Callaway and
 from Callaway to Andrew McCrory, beginning on a Spanish oak near a pile of
 rocks running up the line N 30 W as far as a conditional line made by Barton & Callaway
 thence running square a crop S 60 W to the line on the other side of said tract then
 down the line S 50 E to a post oak stake, thence along the old line to the beginning, also
