hereafter

possess. And the
Wilson
Barton
doth
agree
in
case
she
dies
before
the
said
Rebecca
Hightower,
that all the property
that the said
Rebecca
Hightower
gives
in
this
marriage
contract
shall return to her again and the said
Wilson
Barton
for and in consideration of the home plantation and half the negroes
and
the
value
of
all
her
property
during all her natural lifetime doth
make
to
the

Rebecca
Hightower,
a decent and respectable support and
the said
Wilson
Barton
doth agree, that if the said
Rebecca
Hightower
should not live longer than two years after our marriage, to relinquish
claim to the half of her negroes which she has in this marriage contract
given to me and the said
Wilson
Barton
doth agree at her death
in
the
Rebecca
Hightowers
death
to return
thirty five head of one year old
hogs, and
thirty five pigs and six milk cows and calves, two small yokes of
oxen and six yearlings and one hundred and ten dollars worth of horses and
the said
Wilson
Barton
shall not be accountable for the death of any
those negroes whose names follow, Stephen, Dony Rachael, Jessie Ann
Charles, James, Mahaly, Harriet, Armstrong, Matty and the said
Rebecca
Hightower
doth agree that M. Barton shall have half the increase of those negroes
also if there be any increase, this marriage contract made and entered into
hereunto we have set our hands and seals, this 17th day of January 1859
