

Received Five hundred and thirty four dollars with interest from the  
first day of this month. Now therefore in consideration of the premises a  
consideration the sum of Five dollars by the said William H Campbell to  
the said Michael McRae and paid at and before the sealing and  
delivery of these presents and furthermore for the purpose of indemnifying  
and saving harmless the said William H Campbell from loss damage or  
injury by reason of the premises aforesaid & the said Michael McRae and  
Hence bargained sold so assigned transferred and mortgaged and by these  
present do hereby bargain sell assign transfer and mortgage and by these  
said William H Campbell the following rights, interests and property by all the  
unexpired portion of a lease which I held from Joseph McCadden Jr until the  
first day of January 1855 of land for a certain lot and appurtenances  
situated upon Penncrook, Richland, to office and James Smith in the town  
of Greenville. Together with all the rights, privileges and power incident thereto  
and also a certain house which the said M H Campbell shall erect during  
the unexpired portion of the said lot and which he has the right to remove there  
from on or before the expiration of the said lease.

To have and to hold the balance of the said lease and  
the house aforesaid unto the said William H Campbell upon the following terms  
and conditions to wit that the said William H Campbell shall install the ex-  
piration of the lease aforesaid unto the said premises on the last termes he can and  
at or before the expiration of the said lease shall sell the said house erected by him  
and to the best advantage and that from the rents of the said premises the said  
William H Campbell shall pay annually to Joseph McCadden for the sum of  
seventy four dollars and to Joseph McCadden for the sum of five dollars till  
the expiration of said lease to which they are entitled under their lease to Howard  
for want of the said premises and that the remainder of the said rents and the  
proceeds of the house aforesaid shall be appropriated by the said William H  
Campbell to the payment of the debts which he has assumed as aforesaid and  
that he shall then account for and pay over to the said Howard the balance  
of any in his hands of the said rents and proceeds after paying and satisfy-  
ing the said debts And it is further agreed that the house erected by Howard  
as aforesaid shall be insured against fire at the expense of said Howard  
during the time aforesaid. (The words "or before" interlined before signing)
