 and others beginning on a Rock called Tucker corner Hamming
 24 33 ch 42 to a Stone North 82 W 14 ch to a stone Thence North
 8 E 34 ch 75 to a Rock called Thence South 49 E 11 ch to the beginning
 containing by estimation Thirty Six Acres, the same more
 or less and that the said John A. Gilman as Superintendent of Public
 Lands of the State of a and by virtue of the said Act of
 the General Assembly Grant do Bargain Sell and Release
 unto the said Erastus Smith his heirs and assigns and from Erastus Smith
 unto John Smith his heirs and assigns

Together with all and singular the Hereditament rights
 and appurtenances whatsoever to the said Tract of Land belonging
 in any wise appertaining

To have unto the said John Smith his heirs and assigns forever Quiet
 and undisturbed by any person whatsoever and to warrant and defend
 the before mentioned premises unto the said John Smith his heirs and
