I know all over by these presents that

 in the aforesaid state, in consideration
 of one thousand dollars to me paid by
 G. M. Clanchan, Daniel Funder
 Nimrod Donaldson, B. Runham & J. Westmoreland commissioners of
 the poor in and for Greenville District in the state of aforesaid, have
 granted, bargained sold and conveyed, and by these presents do grant
 bargain sell and convey unto the said commissioners of the poor and their
 successors in office all that tract of Land, situated lying and being in
 the District of Greenville and state of aforesaid. Beginning at a stake J, and
 running N 33 1/2 E 34 to a Hickory, thence N 72 1/2 W 25 to a corner, thence S 32 W 29 S 0
 to a point on the Hickory, thence W 11, 35 to a hickory stump, thence S 4 W 28
 to a small black Gum, thence W 17, 40 to a stake, thence down a branch to a water
 oak, thence S 32 W 11, 40 to a Spanish O, thence N 11, 10 to the ford on the branch
 thence to the beginning corner, containing one hundred and forty two acres of
 land more or less as will appear by reference to the plat made by J. C. Boyd
 and amended dated the 14th of January 1853.

Together with all and singular, the rights, members, hereditaments
 and appurtenances to the said premises belonging or in anywise incident
 or appertaining.

I have and to hold all and singular the premises
 before mentioned unto the said Commissioners of the Poor for Greenville
 District and their successors in office and assigns forever. And I do
 truly bind myself my heirs executors, administrators to warrant and for
 ever defend all and singular the said premises unto the said Commissioners
 of the poor and their successors in office and assigns, against myself
 and my heirs and against every other person whomsoever lawfully claiming
 unto claim the same in any part thereof.
