Know all men by these presents that
Jesse Wilson of the State and District

of aforesaid for and in consideration of the sum of Eight hundred
and seventy five dollars to me in hand paid by Chester W. Walton of
Quibble District in the State of South Carolina have granted
bargained, sold and by these presents do grant bargain, sell and re-
lease unto convey unto him the said Chester W. Walton Five certain
tracts of Land both situate in Quibble District, Tract No. 1 situate
on the South side of water of Mountain Creek water of Ennore
Creek and bounded as follows, VIZ, Beginning at a Sweet
Gum on the bank of the creek running thence S 85° E 7 1/2
to a small Hickory Tr, thence N 20° W 4, the S 10 lines to
a chestnut Tr, on the bank of the creek, thence down the main
due of the creek to the beginning corner, containing two 3/4
half acres to the same more or less. Tract No. 2 situate on the
water of Mountain Creek, water of Ennore Creek being
the said land which Joseph Chandler received as his distribu-
tive share of his father's land and likewise the distributive
share of his brother Wm Chandler, the said land now conveyed is
the land that was conveyed by Joseph Chandler to James White
for containing in the whole seventy five acres more or less, the
land hereby conveyed joins the land of Anne Haddice McCallister
Roberts and others it being two parts of the real estate of his father
Wm Chandler deceased except such part as was conveyed to
Jesse Roberts junior to the conveyance, and hath such shapes
and marks as the plat represents, and which land was conveyed to
me by James T. Mason to me Jesse Wilson, which land is bounded as
follows VIZ, beginning on a white Oak corner running thence N 25° W
3 1/2 the to a post Oak, thence S 35° E to a corner, S 85° E to a corner
at the branch S 1/2° E to a white Oak corner, S 40° W to a corner, thence
S 32° E along the branch to a corner at the creek, thence S 35° W along
the creek to a corner, N 10° W to a corner, S 35° W to the beginning
corner.

aments and appurtenances thereto belonging or in anywise inci-
dent or appertaining. And I the said Jesse Wilson do hereby bind
myself, my heirs, Executors and administrators and assigns forever
to warrant and defend the above granted promise unto him
the said Chester W. Walton his heirs and assigns against myself
my heirs Executors and administrators and against any and every
other person whomsoever lawfully claiming or to claim the same
