sold and released and by these presents do grant, Bargain
sell and release unto the said Thomas Cowell all that tract or
parcel of Land Situate in the State and District aforesaid on
a Branch of Rocky Creek, branch waters of Enoree river con-
taining Forty Acres be the same more or less. Beginning at
west from Stake 3, a.m., thence $\frac{1}{4} \text{ N } 39 \frac{1}{4} \text{ W }$ 14.70 ch to Stake 3, a.m., thence $\frac{1}{4} \text{ N } 2\frac{1}{4} \text{ W } 19.90$ ch to Small Black Oak 3, a.m., thence $\frac{1}{4} \text{ S } 39 \frac{1}{4} \text{ W } 1.50$ ch to
Stake 3, n.m., thence $\frac{1}{4} \text{ S } 82\frac{1}{4} \text{ E } 17.82$ ch to Stake 3, n.m., on Road
thence along the Roade $\frac{1}{4} \text{ S } 12.62$ ch to Bend in said road, thence
 $\frac{1}{4} \text{ S } 44.68.21$ ch to Bend, thence Due South 4.00 ch to Bend, thence
 $\frac{1}{4} \text{ S } 34.60.70$ ch to Bend in Old line, thence $\frac{1}{4} \text{ S } 38\frac{1}{4} \text{ W } 5.70$ ch to final Th-

defend the above mentioned premises unto the said Thomas Cowell
his heirs and assigns against myself my heirs executors
and against every person or persons whomsoever lawfully claiming or
to claim the same or any part thereof. Witness my hand and seal this
the Fifth day of January in the year of Our Lord one thousand eight
hundred and fifty three and in the twenty seventh year of the Inde-
pendence of the United States of America.
