Rob Fan file her bill in the Court of Equity for Greenville District against G W St. Eliz, Mary, Maytal, Baylor Thomas and Joseph and the minor children of Elias D Earle deceased setting forth among other things that he had in the life time of the said Elias D Earle purchased from them a tract of land at the price of Six Hundred Dollars which was paid and payed the said Court to order and decree that a title Thirteenth should be executed to them in trust for the said Somers A V Fan 1st & 2d upon the hearing of the said cause the said Court did order and decree that the Commissioner of the Court at Greenville Court House do execute a title the complainant P W Cheek Trustee of Mrs Somers A V Fan the wife of William Rob Fan conveying to him as such Trustee all that land situate and described in the Bill in this case

We the undersigned all men by these presents that Samuel W Jones Commissioner in Equity for Greenville District in the State aforesaid as well in consideration of the sum of Six hundred dollars by the said P W Cheek as Trustee as aforesaid of the said Mrs Somers A V Fan to the said Elias D Earle in his life time well and truly paid as in obedience to the decree of the Court have granted bargained sold and released unto the presents do grant bargain sell and release unto the said P W Cheek in trust mutually for the exclusive benefit and use of the said Mr Somers A V Fan all that plantation and tract of land situate lying and being in the District of Greenville and State aforesaid containing forty one and one half acres more or less

Beginsing at a Stake on the Boundary road and running thence S 17 E 15.25 to the Head of the road thence N 11 E 5.00 to a pitch pine corner on said road thence S 82 W 8.00 to a wild Cherry tree corner thence S 44 W N 9.40 acuf a branch to a Stake at Rock Adwoods line thence S 31 W 12.00 acuf said branch to a Birch corner near the mouth of said branch, thence S 36 E 2.70 to a white oak bush corner thence S 11 E 14.00 to fork a white oak corner thence S 59 E 3.50 to a red oak corner thence S 17 E 15.25 to a Stake and thence S 82 E 6.00 to the beginning corner.

Together with all and singular the rights members appendants and appurtenances to the said premises belonging or in anywise incident or appertaining thereto.

To have and to hold the premises above mentioned with the said Complainant P W Cheek in trust for the sole use and benefit of the said Somers A V Fan forever and I do hereby by virtue of the said decree bind the said defendants here ab law of the said Elias D Earle deceased to warrant and forever defend held and singular the said premises unto the said P W Cheek trustee as aforesaid and his Successors and Assignees against the heirs of the said Elias D Earle deceased myself
