Know all men by these presents that I
 Waddy Thompson of Greenville District
 in the State, in consideration of Eighteen thousand Dollars to me paid by
 James P. Joyce of the same District and State have granted, bargained, sold
 and released and by these presents do hereby grant, bargain, sell and release
 unto the said James P. Joyce all that piece parcel and tract of Land
 containing One Hundred and Twenty eight Acres, more or less situate
 lying and being in the District and State aforesaid upon both sides of Rich-
 land Creek of Meedy River and upon the South side of the road from the town
 of Greenville to the Town of Samburg and partly within the corporate lim-
 its of said Town of Greenville adjoining Lands of Episcopal Church of Christ
 Church, Clergymen and Ground a Hammonds and having the following boundary
 lines and courses viz Beginning at a Stake \times in the middle of the
 said Samburg Road at the corner of said Land of Episcopal Church
 and running thence with middle of said Road N 78 E fifty chains to a
 Stake at a bend in said road Thence still with middle of said road
 N 66 E eight chains and fifty links to a Stake at the junction of the
 Spartanburgh Road Thence still with middle of said Samburg Road
 S 72 W three chains to a Stake at bend in road Thence still with mi-
 ddle of said road S 62 E Ten chains, and eighty five links to a Stake
 at bend in road Thence still with middle of said road S 70 E five
 ten chains and sixty five links to a Stake \times Thence with Greenwell Hammonds
 line S 45 W thirty six chains and forty five links to a Stake \times (Among
 a Stone) Thence with Clergymen's line N 45 W twenty eight chains
 and sixty five links to a P. O. \times Thence still with Clergymen's line
 S 42 W twenty three chains to a P. O. \times Thence with line of Epis-
 copal Church Land N 32 1/2 W fifteen chains and fifty links to a
 P. O. \times Thence still with line of said land N 18 W eight chains to the
 beginning corner \times Together with all and singular the Right members
 and appurtenances and opportunities to the said premises belonging or in
 any wise incident or appertaining

I have and hold all and singular the pre-
 mises aforesaid unto the said James P. Joyce his heirs and
 assigns forever and I do hereby bind my self my heirs, Executors and
 administrators to warrant and forever defend all and singular the said
 premises unto the said James P. Joyce his heirs and assigns against
 myself and my heirs and against every other person whomsoever law-
 fully claiming or to claim the same in any part thereof
