Witness all men by these presents That I Allen Robinson of Greenville in the aforesaid State in consideration of the sum of twenty five hundred dollars to me paid by C Stearns of Greenville District in the State aforesaid have granted Bargained Sold and Released and by these presents do Grant Bargain Sell and Release unto the said C Stearns all that piece parcel and Tract of Land situate lying in Greenville District and State aforesaid being same Tract purchased by me from Samuel A. Jones. Co. C. 4th Regt as the property of Robert Lee deceased with the following courses and distances Beginning at a black oak 5x on the Table Rock road running thence S 46 1/2 W 25 7/8 to stake 370 thence S 20 1/4 E 20 1/2 to stake thence S 87 1/2 W 10 to stake 370 thence S 32 E 9 1/2 to stake 370 thence N 87 1/2 W 6 1/2 to stake 37 thence S 30 E 29 1/2 to stake 370 thence by N 190 to Post oak 370 thence S 33 E 12 30 to bridge 37 on North Fork of Saluda River thence along said River to old bridge place to black gum stump near said bridge place on Table Rock road thence N 43 1/2 W 38 1/2 to large stone 37 on road to Gap Creek thence to the beginning corner containing Two hundred and eighty acres (280) more or less

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises Adjoining or in any wise incident or appertaining To have and to hold all and singular the premises before mentioned unto the said C Stearns his heirs and assigns forever And I do hereby bind myself and my heirs Executors and Administrators to warrant and forever defend all and singular the said premises unto the said C Stearns his heirs and assigns against me and my heirs and any person or persons whomsoever lawfully claiming or to claim the same or any part thereof
