fifty five and sold as my property by virtue of a
mortgage in favor of T B Moynesworth & W E Earle and
R A Stone that said girl Charlotte was put into my
possession by the said aforesaid Dr S Fair as a Loard
at will in consideration of kind and generous motives
moving him thereto and I do hereby further affirme
and backnowledg'd that I have no right or title whatever
to the said aforesaid girl Charlotte and I do hereby
bind myself my heirs executors administrators and assigns
to deliver to the said aforesaid Dr S Fair his Heirs execu-
tors administrators and assigns the said aforesaid girl
Charlotte whenever I may be called upon so to do

and forever defend all and singular the said premises unto the
the said L H Shumate his heirs and assigns against ourselves and
our heirs and against every other person whomsoever lawfully claiming
or to claim the same or any part thereof Witness our hands and
